## SUPPLEMENTARY GUARANTY AGREEMENT

In order to induce the Company to enter into the Customer Agreement, dated the day of \_\_\_\_\_, 20\_\_\_\_, and made between the Company and as the "Customer" and for other good and valuable consideration, the receipt and sufficiency whereof is hereby acknowledged, the Guarantor hereby agrees to make the following guaranty and agreement with and in favour of the Company:

1. **The Guarantor hereby agrees with the Company that all material times, it will:**
  - (a) **make the due and punctual payments payable under the account of the Company;**
  - (b) **affect prompt and complete performance of all terms, conditions and covenants of the Customer Account Agreement;**
  - (c) **unconditionally guaranty and save harmless the Company from any loss, costs or damages arising out the failure of the Customer to pay any of the aforesaid monies under the terms of the Customer Account Agreement.**
2. This guarantee is absolute and unconditionally and the obligation of the Guarantor shall not be released, discharged, mitigated, impaired or affected by:
  - (a) any extensions of time, indulgences or modifications which the Company extends to the Customer;
  - (b) any waiver or failure of the Company to enforce any of the terms and conditions of the Customer Account Agreement.
3. The Guarantor hereby expressly waives notice of non-performance, non-payment or non-observance on the part of the Customer of the terms and conditions of the Customer Account Agreement.
4. Any notice which the Company desires to serve upon the Guarantor shall be sufficiently given if delivered to the address indicated on the Customer Account Agreement for the Customer.
5. In the event of default under the Customer Account Agreement or this guarantee agreement, the guarantor waives any right to require the Company to:
  - (a) proceed against the Customer;
  - (b) proceed against or exhaust any security of the Customer held by the Company;
  - (c) proceed any other remedy whatsoever in the Company's power.

The Company has the right to enforce this guarantee regardless of the acceptance of additional security from the Customer and regardless of the release or discharge of the Customer by the Company or by others or by operation of law.
